

**FDNE, LLC, dba CAMP TIMBER TRAILS, (referred as CTT for this document),
ACKNOWLEDGMENT OF RELEASE OF LIABILITY AND RESPONSIBILITY**

I am aware that a campground, cabin, and boating area is a natural habitat with many obvious and hidden dangers that make this a potentially hazardous activity. By signing this Acknowledgement, I am voluntarily participating in this activity with knowledge of the dangers involved and hereby agree to accept any and all risks to property damage, personal injury or death.

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, social distancing is recommended. CTT has put in place preventative measures to reduce the spread of COVID-19; however CTT cannot guarantee you, your family or visitors will not become infected with COVID-19. By signing this agreement I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my party and I may be exposed to or infected by COVID-19 while at CTT and that such exposure or infection may result in personal injury, illness, permanent disability and death. I understand that the risk of becoming exposed to or infected by COVID-19 at CTT may result from the actions, omissions, or negligence of myself and others, including, but not limited to, CTT employees, volunteers and other campers. I voluntarily agree to assume all the foregoing risks and accept sole responsibility for any injury, illness or death to myself or anyone in my party.

(initial) On behalf of myself and my party, I hereby release, covenant not to sue, discharge, and hold harmless CTT, its employees, owners, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages costs or expenses of any kind arising out of or relating thereto.

(initial) I understand that guests camping together as a 'pod' are socializing, moving, or co-habiting with full acknowledgement of Covid-19 risks involving the distance between themselves. Campers are asked that while walking outside your assigned cluster to wear masks when encountering people from outside your social pod.

In consideration of my participation in these activities, I hereby release CTT, and the Town of Tolland, and any of CTT's owners, shareholders, directors, officers, employees, agents, heirs, successors and assigns for any present and future claims, including negligence, for property damage, personal injury, disability, or death arising from my participating in these activities. I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, AND I UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.

(initial) I understand that camping/cabins involves certain obvious and hidden risks, including, but not limited to, travel to and from the properties, the existence of natural dangers consistent with other outdoor activities and the possible reckless conduct of other people. These risks also include but are not limited to death, severe injury or minor injury to body parts, sunburn, heat exposure, poison ivy, animal and insect bites, weather-related incidences (flood, tornado, etc.), and water-related activities including drowning in the pond. I further understand that these activities that I participate in may be conducted at sites that are remote from available

medical assistance, and nonetheless agree to proceed with such activities despite the possible absence of medical assistance. I also understand that any equipment provided for my protection may be inadequate in preventing severe injury.

(initial) I also understand that by signing this form I am accepting the responsibility for any damages that may occur during my rental. I UNDERSTAND THAT IF THE PROPERTY IS NOT LEFT IN THE CONDITION THAT IT WAS FOUND, I will be billed at the rate of at least one-night stay or more depending on the condition of the campsite or cabin. Misuse can occur from is but not limited to smoking in the cabin, damage to furniture or fixtures, kitchenware, candle burning damage, garbage which includes food thrown outside, inside or on the ground, bottles or cans of any type burnt in the fire ring, misuse of furniture, defacing of the picnic tables.

(initial) I understand that the waterfront is closed to swimming and boating.

(initial) I understand all food, food equipment and waste *must* be stored in your car. Bears and other critters live at CTT. Food left out *will* attract them. All food waste and trash from your visit must be removed by the participant.

In conjunction with your use of CTT facility the undersigned acknowledges that this is an open, outdoor site that provides staffing for administrative and maintenance services. CTT does not provide emergency service personnel. In the event of an emergency, you must call 911 and report your call. Also call the office when open or the after hours emergency phone listed on the front door of the office.

(initial) I have received, read and understand the safety rules of CTT camping, as well as the General Information and Rules & Regulations, which are incorporated into this agreement. I will abide by the rules and assume full responsibility for all registered guests, visitors, and I, during my stay.

For Parents or Guardians of Minority Age Participants:

FOR PARENTS OR GUARDIANS OF MINORITY AGE PARTICIPANTS: I hereby certify that I, a parent or guardian with legal responsibility for the participant(s) of minority age listed below, do consent and agree to his/her/their release as provided above, and, for myself, my heirs, assignees, and next of kin, I release and agree to indemnify and hold harmless DNE and/or FDNE from any liabilities incident to my minors' involvement or participation in these events as provided above, EVEN IF ARISING FROM THE NEGLIGENCE OF DNE and/or FDNE, LLC, to the fullest extent permitted by law.
